I understand that in the performance of my duties as a member of the PVFD, I may be issued personal protective equipment, communication equipment and/or other equipment required and that I will be held responsible for such equipment and shall maintain and care for and upon my departure from the PVFD, I will return said equipment in good condition. My failure to do so may require me to reimburse the PVFD the replacement cost of such equipment.

I understand I must pay annual dues in the amount of \$10.00 and are payable no later than January 31st of each year and that failure to pay my dues by said date may result in my termination from the department.

I furthermore understand and acknowledge that the Emergency Response field is inherently dangerous and that I may become injured or even killed while performing my duties. I choose to respond so at my own risk and hold harmless the Powderly Volunteer Fire Department, its Board of Directors and Members.
